Doug Robinson, Executive Director, National Association of State Chief Information Officers – Has many innovative examples from NASCIO's recognition awards that he will highlight. Will also discuss how State CIOs are all over the map with regard to the traditional boxes and wires role, innovation, collaboration, transformation, economic development, etc., and how there are a handful of states that have Chief Innovation Officers today and it's still unclear how these mesh with the Chief Information Officers. Will discuss how many governors understand prioritizing education is critical because it is the major driver of economic growth in the states, and how they have come to understand that making state government more efficient and effective through business process redesign, one-stop portals, expanded online business services, performance dashboards (e.g., see http://forward.tn.gov/dashboard.shtml) and now mobile apps serve existing businesses better. Finally, Doug will discuss how many governors have focused on removing the friction of doing business with the state which improves customer service and lowers the costs to businesses.

Bill Schrier, Deputy Director, Center for Digital Government – Will discuss talk the trend – especially among cities – to create a "Chief Innovation Officer" who has a mission to promote economic development and foster startups in the community. Kansas City, Louisville, Philadelphia and Boston all have officers or initiatives along these lines. Bill will also discuss the role of the "traditional" CIO in outreach and economic development. Should a CIO be more inward focused, concentrating on providing technology services to internal customers in the county, or should the CIO also foster collaboration between the County and municipalities or other counties or the state, but again focusing on internal services, or should the CIO also have a role in the local technology community, promoting economic development, use of open data, and other business-formation initiatives?

Phil Bertolini, CIO and Deputy Executive Director, Oakland County, Michigan – Oakland County, MI has been using Egovernment services to help boost economic development. A new web site titled Advantage Oakland was launched in 2012 to help provide a place for companies, from around the world, access to Oakland County and everything that we offer. This type of outreach via the web is making a difference while the evolution of these types of services is opening doorways to recruit companies to our county.

David Zaharchuk, Senior Managing Consultant at IBM Global Services – Will highlight the global location trends and illuminate the issues and provide a current view of the world's location landscape.
