



**Mobile Tour 1: Pennington County Care Campus** 

South Concourse

Attendees will tour the Pennington County Care Campus to learn about a partnership-driven model that expands access to mental health and crisis services through coordinated care across county agencies, community organizations, and private partners. The visit includes the Pennington County Jail and the IGNITE initiative, which supports inmate rehabilitation through education and life skills. The tour will highlight how culturally responsive programming – especially for Native American populations – is integrated into both jail and community-based services, offering a replicable model for counties seeking collaborative, culturally-informed behavioral health solutions.

#### **Mobile Tour 2: Agriculture Research and Production Farm**

Attendees will travel to the South Dakota State University West River Research Farm to gain hands-on experience into cutting-edge research, practices and partnerships shaping the future of Western agriculture. This mobile tour will feature on-the-ground demonstrations of drought-resilient crops, conservation techniques and precision agriculture technologies, followed by a panel discussion with agriculture industry leaders on building collaborative solutions to support farmers and ranchers across the West.

Considering recent regulatory developments, including the withdrawal of the CEQ regulations, the session will address the current landscape of NEPA and what shifting federal guidance means for counties on the ground.
