DUES STRUCTURE Adopted October 2017 Union, Washington

Adopted Dues Structure

- Dues for membership in NCCAE shall be based on the most recent fiscal year budget of the association. The budget shall generally include all administrative funds budgeted for expenditure by the Association and by all subsidiary entities under the direct control of the Association. The budget, for example, would <u>not</u> include claims payments from insurance and related operations and scholarships from association sponsored programs. The budget <u>would</u> include insurance and related operations administrative costs and all conference and meeting expenses.
- 2. The following dues schedule shall be used:

3. In states where more than one Association is a member of NCCAE, each association shall pay dues pursuant to this schedule.
