A Conversation with the Chief of the U.S. Forest Service

*Vicki Christiansen was sworn in as the 19<sup>th</sup> Chief of the U.S. Forest Service on October 11<sup>th</sup>. Chief Christiansen spoke to the WIR Board of Directors about ways her agency is using new authorities granted in the 2018 omnibus and Farm bills to engage with county governments to improve landscape health, reduce wildfire risk to communities and create new opportunities for economic growth in national forest counties.*

Updates to the Federal Disaster Relief Policy (slideshow attached)

*On October 5, the President signed into law H.R. 302, which contains the Disaster Recovery Reform Act (DRRA) of 2018 (DRRA). The DRRA modifies several Federal Emergency Management Administration (FEMA) programs to better assist state and local disaster mitigation, preparedness and recovery efforts. Kayed Lakhia, Acting Deputy Assistant Administrator for Recovery at FEMA, discussed these updates and how counties can tap into new federal resources for disaster assistance.*

Greater Sage-Grouse Conservation

*On June 7, 2017, the Secretary of the Interior signed Secretarial Order 3353, which is aimed at strengthening collaboration between the Bureau of Land Management (BLM) and its state and local partners, with the shared goal of conserving and protecting the Greater Sage-Grouse without impeding economic opportunities. Last year, the BLM released its proposed revisions to the conservation plans for individual states with Greater Sage-Grouse populations. U.S. Department of the Interior Deputy Solicitor Cally Younger discussed the new EISs as well as opportunities for state and local involvement in sage grouse conservation.*
