In 1971, Congress passed the Alaska Native Claims Settlement Act (ANCSA), which divided Alaska into 12 geographic regions. Alaska Natives then organized Regional Corporations, which contain smaller Village Corporations. Native corporations hold title to 44 million acres of land, making

them the largest private landholders in Alaska. Hallie Bissett, Executive Director of the Alaska Native Village Corporation Association will discuss how Native corporations help to generate jobs and economic growth in Alaska Native communities.
