#### Infrastructure Overview and Long-Term Surface Transportation Reauthorization Discussion

Counties own, operate and maintain 45 percent of public road miles and 38 percent of America's bridges, while simultaneously supporting 78 percent of public transit and one-third of the nation's public airports. Annually,

counties invest roughly \$134 billion in the construction of infrastructure and the operation and maintenance of public works. Hear from congressional staff about the outlook for transportation and infrastructure legislation.
