National Broadband Plan for the Future Act: An Updated Roadmap to Universal Connectivity

Former local elected official, Congresswoman Anna Eshoo (D-CA18) has reintroduced the National Broadband Plan for the Future Act which instructs the FCC to update their National Broadband Plan for achieving universal connectivity. The bill would require that the FCC incorporate lessons learned from the impacts of the digital divide on our nation's response to the COVID-19 pandemic. Throughout her time with the FCC, Acting Chairwoman Rosenworcel has been a long-time champion for many key county priorities within the FCC including improvements to national broadband data collection and closing the homework gap through effective broadband deployment.
