Your failure to pay outstanding traffic tickets can result in a license suspension. Driving with a suspended license is a crime. The Drive Legal Program is designed to help you resolve your eligible criminal cases and infractions, and assist you in obtaining a valid Florida driver's license.

So, you want to avoid going to court...

Most people want to avoid going before a judge and prosecutor. You just never know what is going to happen. If this is your concern, and you prefer certainty, predictability, and a structured program, the Drive Legal Program is right for you. The Program diverts your eligible cases away from the court, so you won't have to appear before a judge.

There is a cost, but a BIG savings...

Entry into the Program is \$175 (excluding court costs in criminal cases & traffic school, if applicable). That sure sounds expensive, but cases are removed from collection agencies, saving 40% on each case. Also, for each hour of community service you perform, \$10 will be applied to your payable infractions. Remaining court costs may be eligible for payment plan. Hundreds of Drive Legal enrollees have obtained their licenses by joining the Program and following their counselor's advice.

By performing community service, attending traffic school (in some instances), and by otherwise complying with your counselor's instructions, you may not only clear up your eligible tickets and charges, but you will be helping your community.
