The American County Platform is NACo's permanent policy document containing language that reflects the philosophy and broad objectives of NACo's membership. In addition to developing and promoting the transportation section of NACo's platform, the steering committee considers and adopts policy resolutions, which are generally single-purpose documents addressing a specific issue or piece of legislation. Resolutions draw attention to a topic of current concern, clarify parts of the broadly worded platform, or set policy in areas not covered by the platform. Current policy will guide NACo advocacy until the NACo Annual Conference in July 2016.

- Cross-Jurisdictional or Emergency Resolutions (if applicable)
 Cross-Jurisdictional Resolutions: When introduced, resolutions are initially referred to a primary steering committee. However, other steering committees can claim a resolution if the policy issue is relevant to other steering committee's issue area. If Transportation Steering Committee

members identify a resolution in another steering committee that is relevant to the committee's mission, Transportation Steering Committee members can ask to claim it at this time.

<u>Emergency Resolutions</u>: "Emergency" resolutions are federal legislative or regulatory matters that could not have been foreseen 30 days prior to the conference. Steering committees receiving emergency resolutions may consider them only if two-thirds of the steering committee members present vote to review them. Inaction on the part of a submitter is not grounds for an emergency resolution.

While unmanned aircraft systems (UAS) – also commonly referred to as "drones" – have been used for decades, increased production and matured technology have expanded the commercial and personal use of these systems, which raises a number of issues for counties – both as users and regulators of unmanned aircraft. During this panel discussion, we will explore various domestic applications for UAS by counties and reflect on policy and regulatory developments affecting counties' ability to use and regulate this technology in their communities.

As the owners of 45 percent of the nation's road miles, counties play a key role in road safety. Across the nation, local roads are less traveled than highways but have a higher rate of crashes with fatalities and serious injuries. These crashes are typically caused by a combination of road user behavior, vehicle safety and the roadway itself.
