# **Renewed Rural Development**

USDA's Rural Development subagency oversees a \$216 billion portfolio of grants and loans aimed at bolstering economic development efforts in rural communities across America. In 2017, the Trump Administration realigned the Rural Development subagency, including removing the Senate-confirmed Undersecretary position, and eliminated the White House Rural Council. With NACo's help, the Undersecretary position has been codified under the 2018 Farm Bill and look to the Biden Administration to appoint this critical position for Senate confirmation. This session will discuss the future of the Rural Development subagency under the Biden Administration and what to expect in interagency collaboration on rural economic development.
